- f. assistance for student internships/projects and placement.


3. BACKGROUND OF THE PARTIES

Nature & Scope

Amendment

This document represents the entire agreement between the Parties regarding the subject matter of this MOU and can only be amended or modified by an agreement in writing signed by the Parties hereto.

Confidentiality & Publicity

Any information furnished between the Parties shall be treated as strictly confidential and the same shall not be disclosed by the other Party. However, the information can be shared or publicized with mutual consent.

Indemnification

The Parties hereto agree to hold the other party, its faculty, staff, research scholars, students harmless from any and all claims and liabilities of the nature of legal, financial or otherwise.

Validity

This MOU is valid for Six Months from the date of signing. However, it may be renewed by mutual consent.

Termination

Either party may terminate the MOU for cogent and logical reasons, by giving to the other party 30 days' notice in writing. If the MoU is terminated by either Party, steps shall have to be taken to ensure that the termination does not affect any prior obligation, project or activity already in progress.

Implementation

A Coordination Committee consisting of one faculty member of SP COLLEGE and one Officer nominated by the SNFCL will be constituted for implementation of the MoU.

Legal Effect

This document is not intended to impose any legal obligation whatsoever on either party (whether based in contract, tort or under statutory law). The parties do not intend to be bound by any agreement until both agree to and sign a definitive written contract. Neither party can rely on any promises inconsistent with this paragraph. This paragraph supersedes all other conflicting language.
